Proceedings of Town Trustees Meeting held in the Town of Springfield

The Board of Trustees of Springfield Township met March, 13, 2019 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees, Mike Morris, Shannon Lynch, Clerk Robert Remack, Collector Janine Stroble, Road Commissioner Ron Smith, Assessor Cinda Sausaman. Excused: Don Willett. Unexcused: Arthur Watts.

Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.

The Treasurer's report and minutes of the Board Meeting of March 13, 2019 were reviewed. A motion was made by Shannon Lynch and seconded by Mike Morris to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. A motion was made by Mike Morris and seconded by Shannon Lynch that said bills be authorized for payment. All voted aye. Motion carried.

UNFINISHED BUSINESS: \$615.00 was deposited in the dumpster fund in March.

Supervisor Gary Budd said he was adding to the town budget, the purchase of a salt spreader to be used for small jobs at an estimated cost of \$4,500.00. He said he discussed this with Township Officials and was told an Intergovernmental Agreement between the Town and Road District would allow for the use of the spreader by the Road District.

NEW BUSINESS: A motion was made by Shannon Lynch and seconded by Mike Morris to adopt the 2019 Annual Town Meeting Agenda. All voted aye. Motion carried.

A motion was made by Mike Morris and seconded by Shannon Lynch to adopt the 2019-2020 regular town meeting schedule. All voted aye. Motion carried.

Supervisor Gary Budd reminded the Board of the due date of their Economic Interest Statements.

A motion was made by Shannon Lynch and seconded by Mike Morris to adopt the Intergovernmental Agreement between Sangamon County Treasurer's Office and Springfield Township Concerning Printing and Mailing of Property Tax Bills and the Processing of the First Installment of Property Tax Payments for Taxes Payable 2019 thru 2021. An individual voice vote was taken. All voted aye. Motion carried.

Supervisor Gary Budd said the Sangamon County Vital Records Mobile Unit is scheduled to be available on site for one hour prior to the August 14, 2019 Board Meeting for those residents needing to obtain copies of certain legal documents including birth, death and marriage certificates. They can also register assumed business names and issue raffle licenses.
