Proceedings of Town Trustees Meeting held in the Town of Springfield

The Board of Trustees of Springfield Township met March 09, 2022 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees Shannon Lynch, Mike Morris, Arthur Watts, Shelly Turnbull, Clerk Robert Remack, Road District Commissioner Ron Smith, Assessor Cinda Sausaman.

Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.

The Treasurer's report and minutes of the Board Meeting of February 09, 2022 were reviewed. Supervisor Gary Budd discussed the payoff of the property loan at INB to be voted on tonight. Upon passage of payoff tonight, the Town Fund beginning balance will change from \$104,055 to \$94,283, General Assistance Fund beginning balance will change from \$74,000 to \$72,000 and General Road Fund beginning balance will change from \$62,000 to \$58,000.

A motion was made by Arthur Watts and seconded by Shannon Lynch to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

A motion was made by Mike Morris and seconded by Shelly Turnbull to authorize the payoff of the building loan with INB in the amount of \$15,771.69, \$4,000.00 from the general road fund; \$9,771.69 from town fund ; \$2,000 from general assistance fund. An individual voice vote was taken. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. A motion was made by Arthur Watts and seconded by Mike Morris that said bills be authorized for payment. All voted aye. Motion carried.

UNFINISHED BUSINESS: \$160.00 was collected from the dumpster program held the first Saturday of the month.

32nd St. Ridgewood Ave. Water Project: Supervisor Gary Budd said nothing to report this month.

2022-2023 Town & Rd District Budget Update: Supervisor Gary Budd said changes will be made to the budgets to reflect the payoff of the building loan at INB.

NEW BUSINESS: A motion was made by Shelly Turnbull and seconded by Mike Morris to approve the 2022-2023 regular board meeting schedule. An individual voice vote was taken. All voted aye. Motion carried.

A motion was made by Mike Morris and seconded by Arthur Watts to approve the 2022 annual town meeting agenda. An individual voice vote was taken. All voted aye. Motion carried.

Motion to adjourn was made by Arthur Watts and seconded by Mike Morris. All voted aye. Motion carried.
