***Proceedings of Town Trustees Meeting held in the Town of Springfield***

The Board of Trustees of Springfield Township met April 09, 2019 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees, Mike Morris, Shannon Lynch Arthur Watts, Clerk Robert Remack, Collector Janine Stroble, Road Commissioner Ron Smith, Assessor Cinda Sausaman. Excused: Don Willett.

**Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.**

The Treasurer's report and minutes of the Board Meeting of March 13, 2019 were reviewed. A motion was made by Mike Morris and seconded by Arthur Watts to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. A motion was made by Shannon Lynch and seconded by Arthur Watts that said bills be authorized for payment. All voted aye. Motion carried.

**UNFINISHED BUSINESS:** \$1,130 deposited in the dumpster fund in April, of which \$65.00 was collected on the first Saturday of the month.

Collector Janine Stroble reported the Collectors Office will open on Friday, May 3, 2019 to begin receiving tax payments. She also said there is approximately \$4,800.00 accumulated interest in their account and since the Township Collectors Office will be eliminated in a couple years, the Sangamon County Treasurer advised her to disburse this money to the various taxing bodies within the Township over the next couple years until zeroed out.

**NEW BUSINESS:** A motion was made by Shannon Lynch and seconded by Arthur Watts to adopt Town Budget Ord#2019-2020-03 in the amount of \$296,767.00. An individual voice vote was taken. All voted aye. Motion carried.

A motion was made by Mike Morris and seconded by Arthur Watts to adopt Road District Budget Ord#2019-2020-02 in the amount of \$304,146.00. An individual voice vote was taken. All voted aye. Motion carried.

Chairman Gary Budd said the May 2019 Regular Board Meeting will be held on May 7<sup>th</sup>, the first Tuesday of the month instead of the second Wednesday.

The Regular Board Meeting recessed at 6:30 p.m. to convene the Annual Town Meeting.

The Regular Board Meeting reconvened at 6:40 p.m.
