Proceedings of Town Trustees Meeting held in the Town of Springfield

The Board of Trustees of Springfield Township met April 12, 2022 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees Shannon Lynch, Mike Morris, Arthur Watts, Shelly Turnbull, Clerk Robert Remack, Road District Commissioner Ron Smith. Excused: Assessor Cinda Sausaman.

Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.

The Treasurer's report and minutes of the Board Meeting of March 09, 2022 were reviewed. A motion was made by Mike Morris and seconded by Arthur Watts to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. A motion was made by Shannon Lynch and seconded by Shelly Turnbull that said bills be authorized for payment. All voted aye. Motion carried.

UNFINISHED BUSINESS: \$185.00 was collected from the dumpster program held the first Saturday of the month.

Supervisor Gary Budd reported on the 32nd St. Ridgewood Ave. Water Project. Application for the project has been completed. There are three deals. One pays 100%, one pays 90%, and one requires the residents to pay for engineering fee of approximately \$9,000.00. Mike Johnson with CWLP is writing new bid sheet. Steel pipe will take about 6 months. Plastic pipe will take 30-60 days and it is a lot cheaper. Senator Durbin's office said the Township should know in 4-6 weeks, definitely by June 1st. Supervisor told Mike Johnson the Township applied for \$300,000.00, of which \$175,000.00 is for Ridgewood Ave.

NEW BUSINESS: A motion was made by Arthur Watts and seconded by Mike Morris to pass the Town Budget, Ordinance# 2022-2023-01 in the amount of \$268,508.00. An individual voice vote was taken. All voted aye. Motion passed.

A motion was made by Arthur Watts and seconded by Mike Morris to pass the Road District Budget, Ordinance #2022-2023-02 in the amount of \$343,073.00. An individual voice vote was taken. All voted aye. Motion passed.

Ron Furman has submitted a bid of \$43,585 to blacktop approximately 12,000 of the township parking lot. Upon passage at tonight's board meeting, sealed bids submitted by 2:30 p.m. May 11, 2022 will be accepted at the regular board meeting on May 11, 2022 at 6:00 p.m.

A motion was made by Arthur Watts and seconded by Mike Morris to put out for bid the paving of the township parking lot. All voted aye. Motion carried.

Supervisor Gary Budd reminded everyone that Economic Interest Statements are due by May 1st. He also reported the Township e-mail was hacked and asked if anyone receives e-mail sent under his name to let him know.
