Proceedings of Town Trustees Meeting held in the Town of Springfield

The Board of Trustees of Springfield Township met April 11, 2023 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees Arthur Watts, Shelly Turnbull, Shannon Lynch, Mike Morris, Clerk Robert Remack, Road Commissioner Ron Smith, Assessor Cinda Sausaman.

Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.

The Treasurer's report and minutes of the Board Meeting of March 08, 2023 were reviewed. A motion was made by Arthur Watts and seconded by Mike Morris to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. Added to the bills is \$1,832.01 to Prairie Land, \$87.60 to ILMO, \$318.37 to INB, \$150.00 to Attorney John Kerley, \$1,000.00 to O'Dell Trucking, and \$900.00 to Attorney John Kerley. A motion was made by Arthur Watts, seconded by Shannon Lynch that said bills be authorized for payment. All voted aye. Motion carried.

UNFINISHED BUSINESS: Still closed. No updates.

32nd St/ Ridgewood Ave. Water Project Update: Supervisor Gary Budd said he met with Senator Duckworth and Representative Coffey. He has not heard back from Congressswoman Burdinski or State Senator Turner. Packages were sent to all the above and Senator Durbin.

NEW BUSINESS: Supervisor Gary Budd reported 81% of people voted to stay in Springfield Township on the referendum on the ballot of April 4th election.

The Board discussed a complaint about the burned out property at 124 N. Wesley St. Attorney John Kerley said County Zoning has appointed an outside attorney, Roger Holmes, to figure their authority in the issue.

The Board discussed a new law requiring Townships to form a Decennial Committee to study local efficiencies and must meet for the first time no later than June 10, 2023. It was agreed that the first meeting will be held on May 10, 2023.

A motion was made by Shannon Lynch and seconded by Mike Morris to pass the Town Budget #2023-2024-01. (Supervisor Gary Budd said town carry over money of \$30,000.00 was set aside for potential replacement tax.) An individual voice vote was taken. All voted aye. Motion carried.

A motion was made by Shelley Turnbull and seconded by Shannon Lynch to pass the Road District Budget #2023-2024-02. (Supervisor Gary Budd said potential replacement tax money was set aside.) An individual voice vote was taken. All voted aye. Motion carried.
