The Board of Trustees of Springfield Township met November 09, 2022 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

After discussion by the Board, a motion was made by Shelly Turnbull, seconded by Mike Morris to hold a food giveaway on December 10<sup>th</sup> at 8:00 a.m. A postcard will be sent notifying residents of the giveaway. An ID is required. An Individual voice vote was taken. All voted aye. Motion carried.

After discussion by the Board, a motion was made by Mike Morris, seconded by Arthur Watts to hold a Christmas Party on December 14<sup>th</sup>. All voted aye. Motion carried.

Motion to adjourn was made by Shelly Turnbull and seconded by Mike Morris. All voted aye. Motion passed.
